### ORDER

Whereas the General Election of Village Panchayats and District Panchayat in Daman and Diu held on 19/09/2010, and the Election Commissioner for UTs of Daman and Diu has published the results of General Election vide Notification No. 7-2/EC/DD/2010 dated 23/09/2010.

Now, therefore the Administrator of Daman and Diu in terms of Section 19(1) (a) and (2) of the Daman and Diu Village Panchayat (Amendment) Regulation, 1994 read with Rule 7 of the Daman and Diu(Panchayats) (Election of Chairman, Vice Chairman, President-cum-Counsellor and Vice President-cum-Counsellor) Rules, 1995, fixes 29<sup>th</sup> September, 2010 as the date when the first meeting of the Village Panchayats be convened for election of Chairman and Vice Chairman in each of the Village Panchayat.

The Administrator of Daman and Diu, further nominate all the Presiding Officers as mentioned above under Section 22 of the Daman and Diu Village Panchayat (Amendment) Regulation, 1994, before whom every member of the Panchayat shall take oath of office, after the first meeting of the Panchayat is over.

The Collector, Daman and Collector, Diu shall hold a meeting of all the Presiding Officers, nominated by Administrator to preside over the first meeting of Panchayat, one day before the first meeting of Panchayat to brief them in respect of Procedure of Election of Chairman & Vice Chairman of Village Panchayat.
