2. The KAP (Knowledge, Attitude & Practices) of citizens is a survey which analyses the impact of Knowledge, Attitude and Practices among the electors done through various awareness campaign activities under Systematic Voters Educational and Electoral Participation (SVEEP) of Election Commission of India.

A. B. Study of Institutional and Non-Institutional Issues:

Alongside conducting survey on voters as noted above, the survey work also proposes to have an in-depth study and understanding of the institutional functioning of the entire election machinery engaged in the Lok Sabha General Elections, 2024. Since the elections are over, it is time to assess the successes as well as gaps in implementation, constraints and areas where we need improvements in the system.
